Abstract (en)
[origin: EP1650495A2] The lamp has a base body (20) attached at walls and/or a wall and a room ceiling by a support unit (5). A connecting unit (32) and a reflector (25) for illumination of the ceiling and/or wall areas are arranged at the body. The support unit has a base unit (10) that is attached at the walls and/or wall and the ceiling, and a support part (15) that is attached at the base unit, where the part is adjustable in relation to the base unit.
