[origin: WO2005017425A1] The invention relates to a two-part cooling device comprising a heat-insulating housing (4, 5) and a cooling circuit comprising an evaporator (7), a compressor (20) and a liquefier (24). Said cooling device is subdivided into a first component (3) comprising at least one housing and the evaporator (7), and into a second component (19) comprising at least the compressor (20). Said components (3, 19) can be placed in a variable manner in relation to each other.
