Abstract (en)

The simulator (1) has an operating unit (6) and means (2) to influence it by operating parameters which in turn are influenced by user parameters and/or environmental parameters. The user parameters comprise time variable user parameters and/or the environmental parameters of real, especially time variable environmental parameters, and/or real action data of one or more persons or devices present in the real action sequence, especially vehicles (16), with these parameters determined by a recording device (9) with sensors (14, 19). Independent claims are included for the following: (A) a method for the operating of a simulator with an operating unit and means to influence it; and (B) a system for the executing of virtual/real racing by means of the aforesaid simulator.
