[origin: WO2005035185A1] A machine tool for performing a machine tool function including components adapted to cooperate with each other to execute the machine tool function. The machine tool has a number of constituent parts and a number of sheets of damping material. Each component includes constituent parts with sheets of damping material interposed between the constituent parts. The sheets dampen vibration of the machine tool during performance of the machine tool function.
