Abstract (en)

[origin: FR2861102A1] The section has a framework (2) formed by two hollow profiled cases (3) with a rectangular or trapezoidal section opening towards the top. A flat strip serves as a traffic lane (8) for wheels of a vehicle on the upper part of the cases whose inner spaces allow electrical cable passage for supply of vehicle and/or signalization. The cases are maintained parallel and connected by cross pieces that support a rail for guiding the vehicle. An independent claim is also included for a traffic lane for vehicles.
