Abstract (en)
The present invention provides an aqueous liquid detergent composition, comprising: (a) a cleaning effective amount of an enzyme; and (b) from 0.001 to 0.1% by weight of an anti-oxidant; said composition being substantially free of boron. This liquid detergent composition was found to show enhanced stability of the enzyme material contained therein
