[origin: EP1545130A1] The security modules related to group number in which access rights are to be updated, and encryption keys (KUA1-KUA3) of the modules, are determined. The access rights are encrypted with the keys and authorization messages (EMM1-EMM3) with encrypted access rights and identifiers (UA1-UA3) of security modules are sent to destination. The access rights are decrypted in security modules corresponding to identifiers.
