Abstract (en)

[origin: EP1560448A1] The process involves storing a digital data on a subscriber identity module of a mobile telephone device (10) based on prepaid rights of access, where data contains a cryptographic code. The data is digitally marked in the device by using the code. The data is transferred by the device to a computer based access control unit of a telecommunication network (14). The data is decoded by the control unit for a data transmission. An independent claim is also included for a system for execution of a process for operating a mobile telephone device.
