[origin: WO2005070453A1] The invention relates to monopara-immunity inducers that are based on para-immunizing viruses or viral components of a myxoma virus strain of diseased rabbits that show the general symptoms of the disease. The invention also relates to a method for producing the inventive inducers and to their use as drugs for the regulatory optimization of the para-immunizing activities for use in the prophylaxis and therapy of various human and animal dysfunctions.
