Abstract (en)

[origin: WO2005072421A2] A virtual lottery unit can be utilized by a player to play a virtual lottery. A virtual lottery ticket display is provided to display a plurality of virtual lottery ticket prices. Each of the virtual lottery ticket prices corresponds to a distinct known percentage of a progressive jackpot that can be won with a winning virtual lottery number. The progressive jackpot increases progressive jackpot increases in size based on a portion of ticket sales revenue and that can be won with a winning virtual lottery number. A price selection input receives a selection of the virtual lottery ticket price of which the lottery ticket is to be purchased. Further, a number selection input receives a selection of a virtual lottery ticket number from the player. In addition, a random number generator generates the winning virtual lottery ticket number. A virtual lottery processor compares the selection of the virtual lottery ticket number from the player with the winning virtual lottery ticket number.
