Abstract (en)
[origin: EP1719577A2] Holder for a container (10) in a mixer, comprising retaining strips (11) lying on support strips (8, 9) and a device (13) for tensioning the retaining strips with the support strips, includes a pressure device (14) for forcing the container via the retaining strips against stops (15) within the holder. An independent claim is also included for using a holder as above by placing the container on the support strips, forcing the container via the retaining strips against the stops by means of the pressure device, and then tensioning the retaining strips with the support strips by means of the tensioning device.
