Abstract (en)
[origin: WO2005089834A1] The inventive portable medical, pharmaceutical or cosmetic device comprises a display for operational and/or functional parameters thereof and a control unit provided with one or several control elements for controlling the display and device. The display is embodied in such a way that it is at least partly rotatable with respect to the device housing. In addition or instead of the preceding, the positions of the control elements are modifiable or interchangeable with respect to the device housing. The control functions of at least two control elements which are fixed to the housing (1) of the device are interchangeable. During rotation of at least two parts of the display of the portable device, the display is carried out on the display field by emitting displaying data thereto from a storage at regular intervals in such a way that the display is updated. When several display parts are rotationally movable, stored data is processed by a processing module prior to be transmitted towards the display field.
