Abstract (en)
The present invention discloses a live information supply apparatus of a refrigerator (100) which can supply live information relating to food taken out by a user to the user. The live information supply apparatus of the refrigerator includes a reading means (50) for reading food information from RFID on food stored in the refrigerator and/or a packing sheet and/or a container, a storing means (40) for storing various food information and living information corresponding to the food information, a display means (10) for displaying living information, and a microcomputer (60) for reading the living information corresponding to the food information of the reading means from the storing means, and displaying the living information on the display means.
