Abstract (en)
[origin: WO2005107023A1] The invention relates to a device for connecting an electric drive to at least one supply network as well as several methods for producing such a connecting device. Said device comprises a first contact/terminal unit to which at least one first wire of the at least one supply network can be connected, a second contact/terminal unit to which the electric drive can be connected, and a third contact/terminal unit to which at least one second wire of the at least one supply network can be connected. The first contact/terminal unit is connected to the second contact/terminal unit in such a way that a wire connection can be created between the at least one supply network and the electric drive. The third contact/terminal unit is connected to the first contact/terminal unit or the second contact/terminal unit such that a direct or indirect wire connection can be created between the at least one second wire and the at least one supply network.
