Abstract (en)

The display stand consists of two frames with pairs of uprights (2) linked at the top by cross-bars (13). These are connected by sleeves (5), allowing them to swivel so that they fit on to a standard Euro-pallet (8). Shelves (4) can be hooked over lower cross-bars (14) on the frames.
