[origin: WO2006004784A1] Systems and methods for enhanced network access are described. One aspect of one described embodiment includes receiving a request to connect to a network, the request associated with a user, determining a policy associated with the user, identifying at least one available network connection, determining at least one property of the at least one available network connection, evaluating the property based at least in part on the policy, and selecting the at least one available network connection based on the evaluation. In another embodiment, a computer-readable medium (such as, for example random access memory or a computer disk) includes code for carrying out such a method.
