[origin: WO2006031054A2] A method and apparatus for reproducing data from a recording medium using a local storage is disclosed. The method for reproducing data of a recording medium using a local storage includes (a) reading a binding unit associated with a specific recording medium from the local storage; (b) forming a virtual file structure using a binding operation for combining the binding unit with a file structure recorded in the recording medium; and (c) reproducing data contained in the recording medium and/or data contained in the local storage using the formed virtual file structure.
