Abstract (en)  
[origin: EP1795833A1] A refrigeration apparatus having a refrigerant circuit (20) for performing a vapor compression refrigeration cycle is disclosed. Refrigerant in a wet state, which provides an optimum coefficient of performance (COP) for a present operating condition, is drawn into the compressor (31). If the operating condition changes, the opening of an expansion valve (23) is adjusted such that the suction refrigerant of the compressor (31) is brought into a wet state which provides an optimum coefficient of performance for a new operating condition.
