Abstract (en)

The method involves moving a container, such as bottle (3), along a rotor (7) in a labeling station (8), and applying a label on the container. The labels are printed by imprinting a labeling base material (11) in the station using a printing unit before applying the label on the container, where the printing unit produces a print image depending on an electronic control. The imprinting of the material takes place by a relative movement between the material and the printing unit or a print head of the printing unit. An independent claim is also included for a device for labeling a container.
