Abstract (en)

The invention relates to a baseboard system, comprising a baseboard module (1) for placing a baseboard element against a wall part of a room. The baseboard module comprises a fastening element (2) for fastening the baseboard module to the wall part. The baseboard module further comprises a coupling element for coupling to the baseboard element. Here, after fastening of the baseboard element, the coupling element extends substantially parallel to the wall part. The coupling element further comprises a substantially circular flange.
