Abstract (en)  
[origin: WO2006056669A1] The invention relates to a method of securing a telecommunication terminal (4) that is connected to a module (5) used to identify a user of the terminal. The inventive method includes a step comprising the execution of a procedure in which the terminal is matched to the identification module, consisting in: securely loading (10, 11) a first software program comprising a data matching key onto the identification module; securely loading (12) a second software program which can operate in conjunction with the first software program onto the telecommunication terminal; transmitting (13) a data matching key that corresponds to that of the first software program to the second software program; storing the transmitted data matching key in the secured storage zone of the telecommunication terminal; and conditionally submitting (17) every response from the first software program to a request (14) from the second software program upon verification (15, 16) at the true value of the valid possession of the data matching key by the second software program.
