Abstract (en)
Disclosed is an accessory brush for a vacuum cleaner. The accessory brush comprises: a brush body (110) formed in an elongated shape, the brush body (110) having one or more suction ports; a connection tube (120) rotatably connected to the brush body; and a lateral cleaning means (130) installed on the brush body (110). According to the present invention, a user can conveniently perform cleaning because it is possible to performing cleaning of a recessed area as well as a bare floor without needing to change a basically provided suction brush.
