Abstract (en)  
The device has an iron (10) comprising a soleplate (60) with a vapor production assembly (12) having a pump (76) and a water supply tank (40) from which water is pumped and brought along a flexible pipe (78) to a vaporization chamber (66). The chamber has injection points for injecting the water pumped from the tank for vaporizing it. A programmable control unit (30) supplies water to the iron when a temperature of the soleplate is sufficient for evaporation of water. The control unit supplies vapor to the iron when the production assembly reaches a predetermined operating temperature.

Abstract (fr)  
Ensemble de repassage constitué par un fer (10) et des moyens séparés de production de vapeur (12) afin d'apporter une solution aux utilisateurs pressés, notamment pour le repassage du matin devant le plus souvent être fait dans l'urgence, la présente invention comporte des moyens (40 ; 72, 76, 78) pour que le fer monte très vite en température et soit apte à produire lui même la vapeur nécessaire au repassage en attendant que les moyens séparés de production de vapeur ne lui fournissent cette vapeur.
