[origin: US7937796B2] The invention relates to a wiping mop comprising a mop head (1) provided with at least one cleaning body (2), wherein said mop head (1) is connected to a handle (3), the mop head (1) and a handle (3) comprise a circular foot pedal (4) for wringing the cleaning body (2) by means of a wringing system or a device and the pedal (4) is concentrically associated with the mop head (1) or concentrically encompasses the handle (3) on the side oriented to the mop head (1).
