[origin: WO2006067069A1] The invention relates in particular to a method for manufacturing a circumferential reinforcement for a tyre. The reinforcement comprises at least one wire (9) and an elastomer material (12), wherein the wire and a strip (38) of said elastomer material in a raw state are wound around a form (21).
