[origin: EP1842989A2] A two-part locking nut has inner halves (20a) with an active link to a latch (14) and outer halves (22a) linked to the inner halves by a change-over element (30) controlled via electromechanical means (34) between coupling and releasing positions. The change-over element can be affected by electronic devices designed to check on authorization.
