[origin: WO2006086842A1] A fibre reinforced cement flooring sheet (1) that is suitable for use in wet area flooring, is lower in density than conventional compressed fibre cement wet area flooring, and is nailable. The flooring sheet (1) includes connecting means (2) on longitudinal edges permitting the sheet to be interlockingly engaged with adjacent sheets to form a substantially coplanar support surface, suitable for use in wet areas.
