[origin: WO2006055021A1] A system (100, 102) is used for dynamically pricing products available from one or more merchants. The system (100, 102) sends a first price for a product from a processor (104) to a customer device (108), and receives a report of sale for the product at the first price from a merchant computer. The system then determines a second price for the product based at least on the report of sale for the product at the first price, and sends the second price to the client customer device (108).
