Abstract (en)

[origin: EP1862581A1] The invention concerns a method for operating a domestic appliance, especially a home dryer (1) or a washing machine, and a domestic appliance (1) which comprises an operating mode for treating textiles with steam. According to the method at least one action for protection of an operator of the domestic appliance (1) is taken when an interruption of an active program for treating textiles with hot steam occurs. The method shall prevent that the operator is hurt by the hot steam generated in the domestic appliance. The domestic appliance (1) comprises a control (40) and a memory (41) storing at least one program for treating textiles with steam, wherein the control (40) is adjusted to execute the inventive method.
