Abstract (en)

[origin: WO2006134008A1] The invention concerns a method for presenting a catalogue of multimedia contents transmitted by a server to a communication terminal, in response to a request emitted by said terminal. The invention is characterized in that said method includes a step of adapting said catalogue based on at least one first data representing a current transmission channel and/or an available effective rate, so as to present to the terminal only multimedia contents capable of being transmitted to said terminal at a given time.
