[origin: WO2007014939A1] The invention relates to novel cosmetic preparations comprising an O/W emulsion, said O/W emulsion comprising at least one amphiphilic polymer containing one or more hydrophobic entities (A) and one or more hydrophilic entities (B), the hydrophobic entities (A) being constituted of polyisobutenyls that are modified with terminal, polar groups, at least one component having an HLB value in the range of from 8 to 20 and at least one oil and/or fat phase and water.
