[origin: WO2007014198A1] The invention relates to compounds of structural formula (I): formula (I) or a pharmaceutically acceptable salt, solvate, clathrate, and prodrug thereof, wherein R<SUB>a</SUB>, R<SUB>b</SUB>, and R<SUB>2</SUB> are defined herein. These compounds inhibit tubulin polymerization and/or target vasculature and are useful for treating proliferative disorders, such as cancer.
