[origin: WO2007035974A1] A device and method for charging processing plants, in particular, combustion furnaces (1), is disclosed, in which a flowing process material (3), which has solid components (6) in addition to liquid components (5), is introduced into the processing plant (1), by means of a conveyor line (2) under pressure. According to the invention, advantageous charging conditions may be achieved, by means of mixing the process material (3) before pressurisation.
