[origin: WO2007045238A1] The invention relates to an article of furniture, such as a sitting/standing table, wherein an adjustable element, such as a table top, may be adjusted by a drive unit (8) based on an electric motor. An electrical control unit (6) has a plurality of externally accessible gates and is arranged so as to meet a number of requirements for services and/or optional special functions which may be modified, activated or deactivated with a plurality of external modules (5) configured with a plug (11) when said plug is inserted into a gate (9).
