[origin: WO2007054461A1] The invention relates to a wastewater treatment method for reducing the content thereof in suspended materials, in particular in parasites, comprising a decantation stage consisting in transferring said waters to a decanter at a treating rate greater than 10 m/h, wherein said decantation stage is followed by a fine screening stage carried out with the aid of a screen whose mesh size ranges from approximately 5 micrometers to approximately 25 micrometers
