[origin: WO2007063089A2] The invention relates to a method for the diagnosis of vascular diseases (VE). In said method, the presence or absence of at least one polypeptide marker in a sample is determined, said polypeptide marker being selected from markers 1 - 526, which are characterised by values for the molecular masses and the migration time (CE-time).
