[origin: EP1964616A2] The paint spray pistol (1) has a base (2) with a replaceable paint conductor for carrying paint from a paint inlet of the spray paint pistol to a paint outlet of the pistol. The base has a main contact region for the paint conductor that is formed by an outer base surface. Independent claims are also included for the following: (A) a replaceable ink conductor (B) and an arrangement of a paint spray pistol, a replaceable paint conductor and a paint spray pistol beaker.
