MECHANISM OF ACTION : Regulation, particularly inhibition, of the mGluR5 receptor. The compound 3-(3-chlorophenyl)-N-methyl-N-phenethylpropiolamide has IC50 against the porcine mGluR5 receptor of 0.012 mu M.
