Abstract (en)

The invention relates to a method of treating a mixture (5) containing at least one ester compound having at least one ester bond, in order to enable a dissociation of the ester bond and a re-esterification of the ester compound. The invention also relates to a chemical processing equipment (1) and a mixture (5) containing an ester compound.
