Abstract (en)  
[origin: WO2007123776A2] Methods and systems for gasifying process streams are described. In some embodiments, a method for gasifying a process stream includes gasifying the process stream in a first chamber to generate one or more product gases, transporting at least a portion of the one or more product gases to a second chamber, combusting at least a portion of the one or more product gases in the presence of one or more catalysts in the second chamber to generate a heat energy, and indirectly providing the heat energy from the second chamber to the first chamber as a primary heat source to drive gasification of the process stream.
