Abstract (en)

[origin: EP2023459A1] An ECU (60) detects an effective value and phase of a voltage from a commercial power supply (90), based on a voltage (VAC) from a voltage sensor (74). Further, ECU (60) generates a command current (IR), which is a command value of current (IAC) caused to flow through power lines (NL1, NL2) and in-phase with the voltage of the commercial power supply (90), based on the detected effective value and the phase and on a charge/discharge power command value (PR) for a power storage device (B). Then, ECU (60) controls zero-phase voltage of inverters (20, 30) based on the generated command current (IR).
