[origin: WO2007137797A1] The invention relates to a medicament which, as an active substance combination, contains at least one contraceptively active gestagen as an individual hormone component and at least one insulin sensitiser. Said medicament is particularly suitable for the prophylaxis of or for the therapy of pathological conditions caused by the polycystic ovary syndrome (PCOS).
