Abstract (en)

[origin: WO2007147566A1] The invention relates to a device for treating flexible tubular structures having at least one opening, especially bags (1). Said device comprises at least one gripper (3, 4) holding the structure by its opening, at least one guide gripper (3) and a sequential gripper (4). The invention is characterized in that the guide gripper (3) and the sequential gripper (4) are connected to different guide trains (5, 6) that can be displaced towards each other.
