Abstract (en)
[origin: WO2008006907A1] The invention relates to a cardboard/plastic composite packaging comprising a packing covering (8) provided with a longitudinal seam (6), the packing covering having a folded and sealed package bottom (18) that is provided at one end (16) of the packing covering (8), and to a method and a device for the production thereof, wherein the objective of providing a cardboard/plastic composite packaging, which is also suitable for non-liquid products and moreover is easily stacked, is achieved in that a circumferential web (10) is provided at the upper end (11) of the packing covering (8), and that a lid (14/L) is removably attached to the web (10) in a pull-off manner.
