[origin: WO2008017758A2] Domestic appliance comprising a vat (1) for boiling water and means for removing scale formed in said vat (1), wherein the scale removing means includes a scale collecting vessel (4) provided in the vicinity of the bottom of the vat (1), characterised in that said vessel (4) can be removed through an opening formed on a side wall of the vat (1) or at the top of the vat, said opening being closed by a plug (3) while the vessel (4) having a elongated shape can be extracted from he vat (1) through said opening.
