[origin: WO2008061588A1] The invention concerns a hollow body of plastic material, in particular a fuel tank (1), which was obtained by extrusion blow molding, having at least one line which is stationarily laid in its interior, wherein the hollow body is distinguished in that the line is at least region-wise joined in material bonded relationship to the inside wall of the hollow body.
