Abstract (en)

The method involves manufacturing a weight body (2) by cutting of strips of length desired for the weight body by a longer metal strip, which exhibits a width provided for the body. The strips are cut as the longer strip by a metal band such as coil and/or endless band, where the strips are made from unhardened steel. The strips are brought in a desired shape after cutting by a bending process. The bending process is executed relative to a longitudinal direction of the strips. The strips are cut by a roller sheet such that a longitudinal edge of the body is formed by a natural roller edge. Independent claims are also included for the following: (1) a weight body comprising strips (2) a balancing weight comprising weight bodies and a fastening element (3) a tool for manufacturing a weight body.
