Abstract (en)
[origin: WO2008064895A1] Digital picture frame (1), comprising a display unit (2), for the reproduction of digital image data, at least one memory unit, for storing digital image data, an operation and control unit, for managing the reproduction of digital image data from the at least one memory unit on the display unit (2) and a control input unit (4, 5, 6, 7, 8, 9, 10, 12) for recording inputs to control functions of the operation and control unit. According to the invention, the manipulation and/or operation, in particular with regard to recording and playback of digital image data on the digital photo frame (1), can be improved wherein the digital photo frame (1) comprises a receiver unit which may be operated in a mobile radio network (14), in particular, with a GSM, GPRS and/or UMTS radio network standard for receiving digital image data by at least one communication service of the mobile radio network (14). The invention further relates to a method for transmitting digital image data and/or digital data for acoustic signals in a mobile radio network (14), in particular, by a GSM, GPRS and/or UMTS radio network standard, via at least one communication network of the mobile radio network (14) to a receiver unit operating in the mobile radio network (14), in particular a digital picture frame (1).
