Abstract (en)
A management device 100 for use in an access network 10, 19, 20, 30, 40, 100 including a plurality of data connections 18, 19, 20 between end user devices 10 and an aggregation transceiver device 20 where the connections 18, 19, 20 are aggregated for onward connection through the access network 20, 30, 40, the access network storing in association with each data connection a Dynamic Line Management, DLM, profile which specifies a set of values for a plurality of parameters associated with the respective data connection. The device includes initial profile selection means for, when a line is to be caused to operate in a rate adaptive mode, selecting an initial profile for the line from among the plurality of stored different profiles in dependence upon one or more measurements, or a parameter or parameters derived from one or more measurements, made in respect of the connection whilst operating in another mode.
