Abstract (en)

[origin: EP2119495A2] Method for preparing pigment-containing product (preferably dyes, primers and polishes) comprises: adding a pigment concentrate, from a dosing container in a given quantity, to a base material; and mixing, where for preparing the pigment concentrate, a first pigment-containing raw material and a second pigment-containing raw material are filled in the dosing container and the two raw materials are mixed together in the container. Independent claims are included for: (1) a method for preparing a pigment concentrate comprising feeding the dosing container, in a first step, with a pigment-free raw material and with, in a second step, a pigment-containing raw material; and (2) the pigment concentrate prepared by the above method.
